However, candidates are strictly advised to follow and attend the personal interview on scheduled date. In case of genuineness only, BSSS may consider the above said facility. Such candidate must provide the satisfactory reason along with documentary evidence in written to BSSS. No further claims from candidates shall be entertained after the scheduled date of Interview.

The list has been prepared based on the ratio of 1: 5 of the total number of vacancies (category wise) in order of merit based on their score in the CBT (Computer Based Test) and availability of candidates in the category (as per state reservation roster).

#### Important Instructions for Candidates

- 1. Candidates are advised to report at the venue of Personal Interview at the specified date and time mentioned in their individual Call Letter for Interview.
- 2. Admission to the Interview venue will be on production of the Call Letter. Paste a passport size color photograph, similar to the already uploaded one, in the space provided above in the call letter.
- 3. Shortlisted candidates are being called for the Interview provisionally. Before appearing in the Interview, candidate must ensure that he/she fulfill the eligibility criteria for the post as laid down in the advertisement uploaded on our website.

- 4. All the relevant documents of qualifications and experiences and others will be verified with the designated team of BSSS on the date of Personal Interview. Candidate will be permitted to appear in the Personal Interview, if the essential criteria matches as per the TOR advertised.
- 5. Shortlisted candidates are required to bring with them the original copy and one set of selfattested copies of the following documents:
  - a. Registration Slip, which was generated at the time of submission of online application.
  - Any one valid Proof of Identity viz. Aadhaar Card / Voter ID Card / Driving Licence / PAN Card / Identity Card issued by any Govt. Office/Department etc.
  - c. Age Proof certificate like Birth Certificate/secondary examination Certificate.
  - d. Mark Sheets & Certificates of all academic & technical courses related to the post applied for and essential according to the advertisement.
  - e. All work experience certificates related and essential as per TOR/Job description advertised for the position applied. (as a proof of experience, in the absence of proper work experience certificate, candidates may submit the joining letter and relieving letter/order and in case of serving employee, latest salary slip/certificate may be considered)
  - f. Valid Caste Certificate, under which you have applied for the respective post (if applicable).
  - g. Candidate belonging to EWS (Economically Weaker Section) need to produce the certificate as specified in govt. rule.
  - h. Domicile Certificate, candidate who claims residence of Bihar (for candidate who claims reservation)
  - Valid Disability Certificate as per Govt. Notification, if applicable
  - j. Valid Freedom Fighter Certificate as per Govt. Notification, if applicable
  - 6. If candidate is currently working in Central/State Govt./Semi Govt. Organization / Public Sector Undertaking, he/she will have to furnish a "No Objection Certificate", issued by your employer, at the time of Personal Interview.
  - 7. Please note that the Candidates' Name, appearing in the Call Letter, should exactly match with the name as in the photo identity proof. Female candidates, who have changed their names post marriage, must take special note of this. If there is any mismatch between the names in the call letter and Photo identity proof, the candidate will not be allowed to appear for the Personal Interview. The candidates, who have changed their names, will be allowed only if they produce Gazette Notification/ Marriage Certificate/ Affidavit.
  - 8. If at any stage of recruitment/selection, it is found that the candidate does not fulfill the eligibility criteria and/or that he/she has furnished incorrect/false information/certificate/documents or has suppressed any material fact(s), his/her candidature will stand cancelled. The decision of Chief Executive Officer, BSSS in any matter relating to the recruitment at any stage of the recruitment process will be final and binding upon the candidates.
