- 1. Assist DTO in organizing direct observation of treatment for MDR-TB patients and MDR TB drug logistics management and in preparation and implementation of intensified TB-HIV package of services in the district.
- 2. Facilitate MOs, STSs, STLSs, LTs and other health system staff to subject all MDR-TB suspects to appropriate diagnostic tests for diagnosis of MDR-TB at an RNTCP accredited laboratory.
- 3. Identification and training of DOT providers for MDR-TB patients and maintenance of a directory of such DOT providers at the TU and district levels.

- 4. Organizing training of staff in TB/HIV collaborative activities, including intensified TB-HIV package of services at the district level, where ever applicable.
- 5. Maintain and update the district level DOTS-Plus treatment cards, and other records and reports.
- 6. Supervise all DOTS Plus treatment observation centres once in quarter.
- 7. Assist the DTO for providing training to the staff of health facilities under his/her jurisdiction to carry out DOTS- Plus related activities.
- 8. Establish liaison with private practitioners, NGOs and other sector dispensaries/hospitals to provide DOTS-Plus services as per the programme guidelines.
- 9. Prepare and maintain a directory of ICTCs ART Centres, Community care Centres and NGOs working in NACP in the district and the collaborating RNTCP Centres.
- 10. Establish linkages with DTC, DAPCU, collaborating NGOs and hospitals of the district.
