#### **DUTIES and RESPONSIBILITIES**

Consultant Family Planning will be responsible for providing support to concerned officials in Preparation of Annual Plan, implementation of the programme in the periphery, compilation and analysis of data for action and review of the Family Planning programme and associated issues. The State Consultant (Family Planning) He will also be responsible for providing strategic inputs for different health activities related to family planning.

A degree in Public Health (MBA) preferably from reputed public health institutes is required along with at least 3 years of experience in health sector at middle management level with a broad understanding in the field of RCH/Family Planning programme. She/he must have highly developed writing, drafting skills in Hindi and English as also oral presentation skills as well as a demonstrated capacity perform as per expectations of supervisors. He should be able to comfortably work on computers and well conversant with MS Word, Powerpoint and Exel and other common official applications.

The candidate applying for the post must be comfortable working in collaborative environment with many partners and stakeholders.

#### **DUTIES and RESPONSIBILITIES**

Consultant Family Planning (Regional) will be responsible for providing support to in Planning, implementation and Monitoring and review of FP Programme in the concerned district/blocks within the division. He will also be responsible for providing strategic inputs for different health activities especially in the field of family planning. He would be responsible to ensure that the activities relating to FP programme are implemented as per directives of Government of Bihar and Government of India. Extensive travelling would have to be undertaken.

#### **ROLES & RESPONSIBILITIES AND REPORTING:**

Under the overall managerial supervision of the Regional Director–Health & Family Welfare & State Family Planning section of State Health Society, the Regional FP Consultant will be responsible for comprehensive planning and implementation of the Family Planning Component of NRHM in all the concerned districts under the region. The regional consultant is expected to facilitate the process of

preparation of the district family planning action plans in collaboration with the district family planning nodal officer. As part of the work, the Consultant, under direction of the Regional Director, will interact with the districts and will undertake extensive field visits to the districts for programme implementation and monitoring. The Candidate applying for the post must be comfortable working in collaborative environment with many partners and stakeholders.

Specifically the roles and responsibility will be:-

- To develop FP action plan based on the strategies and activities under NRHM to be pursued in the districts.
- To examine FP activities proposed in the PIP in the Region and take lead on facilitating the implementation of the activity.
- To provide support to the district nodal officers-FP on developing district specific activities/trainings/schemes etc.
- To provide inputs to districts to develop and revise their action plans for implementing FP section of the district PIP.
- To provide facilitation & technical support in starting new static FP centres in the district as per State norms.
- To develop training plan for FP and provide inputs needed by the districts and implement the same as per plans. Extensive monitor FP service provision and Schemes of FP Program.
- To take lead in organizing and conducting monthly review meeting of FP activities/Counsellors with regional teams. To participate in meetings related with FP at block/district/State/National level.
- The consultant will submit his/her quarterly report on above areas to the State Family Planning Nodal officer.
